AUCTION NOTICE

Sealed tenders are invited to dispose off unserviceable/condemned vehicles and materials on 'as is where is basis' so as to reach the office of Director General of Police, Panaji, upto 10:30 a.m. on 04.09.2009. (i.e. Hero Honda -24, Yamaha- 02, Ambassador cars- 6, Mahindra Jeeps- 7, Trax Jeep- 1, Bajaj Tempo- 3, Tempo Trax- 2, Bullets 350cc- 12, Tata Sumo- 8, Tata Sumo Ambulanace-01, Maruti Gypsy- 7, Tempo Travellor- 3).

Tenders will be opened in the office of D.G.P (GOA) on same day at 11:00 a.m. during which period the tenderers or their authorised representatives may remain present. Tender catalogue along with terms & conditions can be obtained from the same office on all working day\hrs. on payment of Rs.500/- (non refundable) per set from 21.08.2009 to 03.09.2009.

Lots shall be available for inspection from 21.08.2009 to 03.09.2009 (upto 4 p.m.) as per details of locations mentioned in the tender catalogue.


- a) Security deposit will be at the rate of 10% of the bid value or minimum Rs.2000/- whichever is higher in the case of disposal of vehicles and heavy machinery/equipments etc. and at the rate of Rs.1000/- per lot in case of disposal of furniture and other items. The same shall be in the form of D.D./Pay Order/D.C.R. of any scheduled Bank drawn in favour of the Jt. Director of Accounts, DGP's Office, Panaji, Goa, payable at Panaji, and to be enclosed by all bidders along with their offer.
- b) The highest bidder(s) shall deposit 25% of the bid price on the same day in form of D.D./Pay Order/D.C.R. of any scheduled Bank drawn in favour of the Jt. Director of Accounts, DGP's Office, Panaji, Goa, payable at Panaji, failing which the amount deposited as per clause (a) above shall stand forfeited with respect to such lot(s).
- c) The balance 75% of highest bid value of each lot should be paid by the bidder within 7 days from the date of issue of sale letter/acceptance letter by the Department to the successful bidder.

This balance payment shall also be in the form of Pay Order/D.D./D.C.R. of any scheduled Bank drawn in favour of the Jt. Director of Accounts, DGP's Office, Panaji, Goa, payable at Panaji, in case of failure to make balance payment in time the amount deposited as per clause (b) above shall stand forfeited.

The successful bidder shall lift lot(s) within 3 weeks of receiving intimation letter/Delivery order from Department and failure to do the same, the amount deposited as per Clause (b) and (c) above shall also stand forfeited.

Disposal of all condemned articles are exempted from Sales Tax.

The Department reserves the right to accept or reject any or all bids without assigning any reasons thereof.
